Cybersecurity Posture Assessment	This is an interview-based qualitative assessment to determine the current state of an organization's cybersecurity defense implementation. Organizations respond to 127 questions using a built-in rubric to score themselves from 0 to 4 on each question. Deliverables include an 8-page report showing the organization's cybersecurity strengths and weaknesses, and how they rate in 22 categories, against the NIST CSF, TX DIR CSF, and COS Controls v8. One hour of consulting is included.	\$275
CIS Controls Training	CIS Controls consists of 18 control groups and 153 control safeguards (controls). Training is tailored to organizational needs and can include controls orientation, elaboration, and/or implementation consulting.	\$135/hour
